**MAJOR CRACKDOWN ON ILLEGAL LIQUOR SALE AND SUPPLY BY DNH
POLICE**

TOTAL LIQUOR AND VEHICLES WORTH RS. 50,000,00/- SEIZED IN 02 CASES.

Under the supervision of Superintendent of Police, Dadra and Nagar Haveli and Sub Divisional Police Officer, Dadra and Nagar Haveli, the various teams keep a track on illegal activities related to illegal liquor sale and supply.

1. On 15.03.2018 at about 1815 hrs, as per secret information, Incharge Special Branch and team had carried a raid at the staff room of the Fort Hotel, Samarvarni and seized total 628 boxes worth Rs. 17,37,992/- including IB Whisky, Officer's Choice, Tuborg light Beer, Royal Stag Whisky, Carlsberg Beer, Royal Special Whisky, Haywards 500 Beer, Tuborg Strong Beer, Kingfisher Can Beer, Elephant Carlsberg Beer, OC Blue Whisky, DSP Black Whisky, Antiquity Whisky, Bagpiper Whisky, Blender Pride Whisky, Raseblue Vodka, etc. and Eco Car No. GJ-21-DC-1395 of Rs. 2,50,000/- Eco Car No. GJ-15-CF-7165 of Rs. 2,50,000/- and Fortuner Car No. GJ01-KG-1956 of Rs. 20,00,000/- total worth of Rs. 42,37,992/- which was without pass/permit.

The case has been registered at Silvassa Police Station vide Cr. No. 74/2018 u/s 36(1) (A) & (F), 41 of Dadra and Nagar Haveli Excise Regulation Act, 2012.

Accused 1. Ketan Natwarsinh Solanki, r/o. Ahir Faliya, Samarvarni, 2. Dharmendrakumar Baijnath Yadav 3. Nirdosh @ Vinod Rajasinh Yadav both r/o. of Vanmali Park, Samarvarni 4. Ajit Jaiprakash Jha 5. Rameshkumar Pruhvi Mandal both r/o. Kachigam road, Athal have been arrested on 16.03.2018 at 1030 hrs at Silvassa and remanded to police custody.

2. On 16.03.2018 at about 1600 hrs, Staff of Rakholi carried a raid at behind Milan Godown in the shed of Mahendra Rathod's building at Madhuban Road, Rakholi and seized illegal liquor of total 183 boxes of worth Rs. 5,01,696/- including Signature Whisky, Royal Challenge Whisky, Royal Stad Whisky, Magic Moment Vodka, Imperial Blue Whisky, Blenders Pride Whisky, Heiniken Lager Beer, Kingfisher Ulta Lager Beer, Kingfisher Premium Lager Beer, Kingfisher Strong Beer, Haywards 5000 Beer without pass/permit and WagonR Car of Rs. 4,00,000/.

The case has been registered at Silvassa Police Station vide Cr. No. 75/2018 u/s 36(1) (A) & (F), 41 of Dadra and Nagar Haveli Excise Regulation Act, 2012.

Accused 1. Nilesh Rana Ahir, r/o. Vapi Pandor, Ahir Faliya, Gujarat 2. Rajesh Radiya Ahir r/o. Borigam Char Rasta, Gujarat have been arrested on 16.03.2018 at 2300 hrs at Silvassa and remanded to police custody.

Further, investigation is in progress in both the cases.
