

## PRESS NOTE

- **HEAVY CRACKDOWN ON ILLEGAL LIQUOR BY DNH POLICE**
- **LUXURY CAR SKODA LAURA USED FOR TRANSPORTATION OF LIQUOR SEIZED IN A CASE.**
- **ILLEGAL LIQUOR OF WORTH RS. 6 LACS SEIZED**

(1) On 07/02/2018, an information received through reliable sources that large quantity of liquor is kept in the house of Shri Kalpesh Ramesh Patel resident of village Falandi, Patelpada. Immediately a Crime Branch Team headed by PI H. C. Rathod alongwith police staff on the direction of Shri Manasvi Jain, Sub Divisional Police Officer and overall supervision of Shri Sharad Darade, IPS, Superintendent of Police conducted a raid in the house of Shri Kalpesh Ramesh Patel resident of village Falandi, Patelpada. Efforts were made by the Crime Branch and seized the illegal liquor 215 Box contains 24 Can Beer (500 ml.) of make BOHEMIAN KING of worth Rs. 3,09,600/-.

Accordingly, an offence vide FIR No.33/2018 u/s 36(1)(C), 49, 51 of Dadra Nagar Haveli Excise Regulation Act, 2012 against Shri Kalpesh Ramesh Patel was registered at Silvassa Police Station. The accused person ran away from the place of incident and he is still absconding. Investigation of the said case is entrusted to ASI R. G. Patel for further investigation.

(2) On 08/02/2018, an information received of carrying illegal liquor on vehicle make Skoda Laura by the Galonda Out Post staff. During patrolling they intercepted the four wheeler Skoda Laura bearing registration No.GJ-05-CK-2276 and found a person namely Yatin Suresh Patel r/o Billimora, Khaparwada. It is revealed that they were carrying illegal IMFL liquor alongwith driver Mr. Vikas who had fled from the spot. During the search of vehicle IMFL liquor of worth Rs.37,600/- and vehicle of worth Rs.4,00,000/- was seized.

Accordingly, an offence vide FIR No.34/2018 u/s 36(1)(A)(F), 41 of Dadra Nagar Haveli Excise Regulation Act, 2012 against Shri Yatin Suresh Patel r/o Billimora, Khaparwada and Shri Vikas resident of Surat was registered at Silvassa Police Station. The accused person namely Shri Yatin Suresh Patel r/o Billimora, Khaparwada has been arrested on 09/02/2018 at 0015 hours and Shri Vikas was fled from place of incident and he is still absconding. Investigation of the said case is entrusted to HC N. M. Patel for further investigation.

(3) On 09/02/2018, an information received of carrying illegal liquor on a truck bearing registration No.GJ-16-W-8162 was coming at Masat village. Immediately PSI C. L. Tandel deputed Out Post staff to conduct for vehicle checking passing through Masat village. During the vehicle checking at Kudacha village the said truck was

found. On search of the said truck, the following type of liquor was seized.

During the search of vehicle IMFL liquor of worth Rs.2,09,178/- and the truck was seized.

Accordingly, an offence vide FIR No.39/2018 u/s 36 (1)(A)(F), 41 of Dadra Nagar Haveli Excise Regulation Act, 2012 was registered at Silvassa Police Station. In this regard, three persons namely Jitendra Yadav, Shri Karansingh Yadav and Shri Bholashyam Sen were also arrested who were present on the spot by DNH police. Investigation is in progress.
