I, the andersingned respectfully beg to state as under:-

(1) I am residing at the above mentionsd address alongwith my family. I am government servant and thereby maintaining my family.

(2) On 09/03/2016, at about 08.00 p.m. I was going to silvassa for my personal work alonwith (1) Mr. Sandeep Ramkeval kanojjiya and (2) Mr. hemaraj

Natvarsinh solanki in my maruti suzuki Eartiga car bearing Registration No. DN-09-J-0065.

(3) while i come near swaminarayan Temple, al of sudden accused came with i20 car No.DN09 L 0214 frome Silvassa side and from other lane and all of sudden took a turn towards Swaminarayan Temple at very high speed and in rash and negligent manner without giving any signle or Horn Light to show his intention to take turn to my side prior taking turn.

(4) Iwas on my correct side on straight way and all of sudden he come with his said car and dashed his car on front side of my car,Thus, his act was endangering to life. He had driven his car in rash anad negligent manner.Due to dash, my car got damaged very heavily. Entire front side show,bumber,rediator,bonnet,haed ligt and engine etc. got damaged In fact,Just before said dash by the accused, I had crossed speed breaker in very slow speed. Therefore, my car was slow speed, If, My car would have been in high speed, myself and my above named co-passenger and accused and his co- pessengers might have been injured seriously but, Due to slow speed of my car, our lives saved.

(5) Immediately after the said incident, I had helfed the accused to reach to hospital to his co-passenger who was injures by coming into contact with broken glass of car of the accused Thereafter, I infomed police officer attached to athal out post through my mobile phone No. 8511160665 to his mobile 9925107533 about the above mentioned incident .He advised me to reach my car before Police.Therefor .I went to Naroli our Post and gave custody of my car tonaroli out .My said car was taken to Naroli out Post by toeing.At that time I Had given written report addressing to PSI Naroli regarding the said incident .But ,it appears that Police has not taken any action on my said written report ,my Car is still lying in Out post ,Naroli.

(6) I have to state that as accused is serving in Police Department. Therefore, policeis blased against me. Because, though my compaint is well in time. my car is already given to the custody of police immediately. Even though, after two daye from the said incident and though accused is at complete fault, Silvassa police has registred his false complaint against Report me as FIR No. 107/2016 in fact, my complaint is first information Report. and therefore it ought to have been registrered as FIR But, police has acted in complete hostile manner against the procedure as provided to your goodself with the request to issue direction to silvassa police to registrar my complaint on the basis of my first complaint given in midnight between 09/06/2016 and 10/06/2016

(7) Therefore,it is earnestly requested to issue direction to silvassa police to register my compaint on the basis of my sirst compalint given in midnight between 09/06/2016 against the accused for the above mentioned offence and help me to get justice and oblige.
