- [2] I State that I have been constantly receiving messages & Whatapp messages demanding illegal money from Vimlesh Shukla of Silvassa since 23.08.2016 from his mobile number 9723466882 on my mobile number and also on my father's mobile number Which is in possession of my mother and he has been harassing me and my mother mentally for the illegal demand of Money and asking me to pay him. When he had met me in Silvassa Town at that time he had again demanded money from me at that time I have denied to pay the same at that time said Vimlesh Shukla threatened me that he Will see me beat me at any time in market in the presence of the public by his men.said Vimlesh Shukla Shall harm me Physically and to defame my image in Society as per his Threat given to me. said Vimlesh Shukla has Intentionally put me in fear to cause injury to me and thereby

said Vimlesh Shukla dishonestly induces me and put me in fear to Deliver the above said money Which was demanded by said Vimlesh Shukla. Said Vimlesh Shukla has sent the said Messages by SMS and Whatsapp to me up to 30/12/2016. said all said massages are saved in my mobile handset and I am ready to give its print copy for your perusal.

- [3] Thereafter on 19/02/2017 at about 09.30 pm one mobile call came from 08140736733 on my mobile. I have received the said call on being identified as Jigar speaking the unidentified caller told me the he has accepted a contract from further unidentified person Which he do not wish to disclose his name and further Stated that said person has given him supari of Rs. 20,0000/-[Rs. Two Lakhs only] to me and my other four gang members. He further state that this money is to harm you Physically and to defame your image in Society. Thereafter he has disconnected the said call. I feel seriously threatened for my self and my family member's Life. I strongly suspect that Mr. Vimlesh Shukla, Residing at Gurudev Complex Phase III of Silvassa has given said supari to that said unknown caller and his gang. I personally feel that Mr. Vimlesh Shukla who has been harassing me by sending SMS and Whatsup messages from his mobile phone number 09723466882 on my mobile phone for demanding illegal money from me and has given this supari[Contract] and I also feel the above said all person will harm me physically and mentally and damage my life and my family member's life and my properties.
- [4] I further feel that the above said unknown caller and his gang at any time can come at my place and any time they can neat me and defame my image in society and I am in fear that they will execute supari[Contract] and Kill me at any time. If at any time I am being harm ny any way even accidentally, the said suspect person and said unknown caller and his gang will be fully responsible.

It is thereafter, requested to your good self to deeply inquire the above said matter and to arrest the above said Vimlesh Shukla and said Unknown caller and his other four unknown person and punish them according to the provisions of law for Extortion, Criminal Conspiracy, Defamation, Threat and other such offences.
